Schools as per Affiliation Bye laws of the Board and disburse the salary through Bank & also submit photocopy of acquittance roll after complying with the above condition.

The school is required to ensure that no staff member may be appointed / continued in the

services of the school who has attained the age of superannuation.

The School Managing Committee is required to be reconstituted having each of 02 parents representative, teacher representatives and 02 Principals of affiliated schools preferably of Kendriya Vidyalaya / Jawahar Navodaya Vidyalaya.

The school is required to maintain the reserve fund as per strength of the school in the joint names of Secretary, CBSE and Manager of the school as per provisions of Affiliation Bye-Laws of

the Board and copy of FDR so created be furnished to the Board for record purpose.

As per online application, the school is running its classes from two sites. Therefore, the school is required to clarify in details status of both the sites including infrastructure, the classes that are running distance between two sites, site for which NOC is issued, area of each site etc. duly supported with documentary evidence.

The school Authority is required to submit the self declaration/ certificate duly attested by
